May kindly see the property statement received online from Sri Praduman Singh, Addl. Civil Judge (Junior Div.), Lucknow, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.13,08,630/- and total deductions/savings/investment against GIS, PPF and Income Tax is Rs.83,880/- and the balance of his savings bank account(s) is also increased by Rs.31,745/- in this financial year from previous year's balance, total of which is Rs.1,15,625. Thus, a sum of Rs.11,93,005/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2019-2021 (2019-20 & 2020-21).

It is also pertinent to mention here that the his father have annual income of Rs.3 lac & Rs.5 lac through pension and agriculture respectively in both financial year.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into U.P. Judicial service, online against Case Id : P00039482021(Old Case Id : 6096) and the same has been processed before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 14.09.2023. As such, there is delay in submitting the same for which the officer stated in the remark column, that (in his verbatim) *"due to Institutional Training and some time lapsed to collect the documents and statements from the banks, due to which I could not submit my property statement. The inconvenience caused in your good self is highly regretted. I sincerely apologise for the same."*

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Praduman Singh, Addl. Civil Judge (Junior Div.), Lucknow, be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
