May kindly see the property statement received online from Smt. Mona Singh, Addl. Civil Judge (Sr.Div.)/ACJM, Lakhimpur Kheri, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary and arrears is Rs.29,43,502/- (Rs.28,68,048/- from Salary including arrears of Maternity Leave and Rs.75,454/- from SB account interest) and total deductions/ repayment/ savings/ investment against GIS, PPF, NPS, Car Loan repayment and Income Tax are Rs.12,70,963/- and the balance of her savings bank account is also increased by Rs.15,08,068/- in this financial year from previous year's balance, total of which is Rs.27,79,031/-. Thus, a sum of Rs.1,64,471/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2020-2022 (2020-21 & 2021-22).

It is also pertinent to mention here that her husband is a PCS Officer, who presently holds the post of S.D.M. have annual income is approx. Rs.8,85,000/- & Rs.9,60,000/-, for the financial year 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20), online against Case Id : P00023862021 (Old Case Id : 4517) and the same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has firstly submitted her movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 20.09.2023. As such, there is delay in submitting the same for which the officer has stated that (in her verbatim) "*due to lots of work and lack of technical knowledge about the use of e-service portal. I would like to apologize for the late submission*", in the remark column.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Smt. Mona Singh, Addl. Civil Judge (Sr.Div.)/ACJM, Lakhimpur Kheri, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders?
