In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2021-23 (2021-22 & 2022-23), her gross income is Rs.48,97,318/-(Rs.45,53,918/- from salary and Rs.3,43,400/- from House Rent) and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Repayment of home loan, Payment of Plot Purchase and Insurances are Rs.40,55,256/-. The balance of Rs.6,23,772/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.14,65,834/-(Rs.8,42,062/- from salary and Rs.6,23,772/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2021-23 (2021-22 & 2022-23).

It is pertinent mention here that's Officer's Husband (Senior Manager Law in Punjab National Bank, Agra) having annual income was Rs.15,92,786/- for the financial years 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id-P00054562022, Which had already been seen by Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She had submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 14.09.2023 on eServicesJo portal. As such, there is no delay in submitting the same.
