May kindly see the property statement received online from Sri Manjeet Singh Sheoran, Presiding Officer, Motor Accident Claims Tribunal, Ghaziabad regarding submission of complete statement of movable properties acquired/held by him or any member of his family of the financial year 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2021-23 (2021-22 & 2022-23), Total Gross salary from income is Rs.45,41,990/and total deductions/savings/ investment against GIS, Income Tax, NPS, Car loan and mediclaim insurance policy are Rs.15,26,827/-. Thus, a sum of Rs.30,15,163/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years. And the balance of his savings bank account(s) is also reduced for Rs.4,32,611/- in this financial year from previous year's balance.

It is pertinent to mention here that the Officer's wife earns annual income of rent from flat of Rs.1,56,000/- in each financial year. She has also earns interest from FDR & Savings Bank a/c. Officer has also FDR of Rs.5,21,000/- , which has encashed in the financial year 2021-22.

In this connection, it is submitted that the officer has already submitted his property statement of the financial year 2019-21 online, which has been seen online by Hon'ble Mr. Justice Rohit Ranjan Agarwal, the then Administrative Judge, Gautambuddha Nagar.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-23 (2021-22 & 2022-23) vide online dated 16.09.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Manjeet Singh Sheoran, Presiding Officer, Motor Accident Claims Tribunal, Ghaziabad be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad for His Lordship's kind perusal and orders?
