May kindly see the property statement received online from Smt. Alka Bharti, Addl. District & Sessions Judge, Muzaffar Nagar, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.40,50,063/- (Rs.40,22,499/- from salary and Rs.27,564/- from Share dividend) and total deductions/ repayment/ savings/ investment against GIS, PPF, NPS, various Shares and Income Tax are Rs.24,55,756/- and the balance of her savings bank account is also increased by Rs.3,91,219/- in this financial year from previous year's balance, total of which is Rs.28,46,975/-. Thus, a sum of Rs.12,03,088/- was therefore available with her to meet out the household expenditure of her family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

It is also pertinent to mention here that the her husband is a Judicial Officer having annual income of Rs.19,59,401/- & Rs.25,76,619/- in the both financial year respectively.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20), online against Case Id : P00003262021 (Old Case Id : 2335) and the same has been seen by Hon'ble Mr. Justice Rahul Chaturvedi, the then Administrative Judge, Pratapgarh Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 17.10.2023. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Smt. Alka Bharti, Addl. District & Sessions Judge, Muzaffar Nagar, be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
