In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.45,36,020/-(Rs.45,19,127/- from salary, Rs.16,893/- from Share dividend) and total deductions/savings/investment against GIS, NPS, PPF, Insurance, various Shares and Income Tax are Rs.35,62,541/-. Thus, a sum of Rs.9,73,479/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22) and the balance of his savings bank account(s) is also decreased by Rs.9,154/- in this financial year from previous year's balance.

It is also pertinent to mention here that his wife is a Judicial Officer having annual income of Rs.19,09,366/- & Rs.21,41,697/- in the both financial year respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id: P00003272021 (Old Case Id: 2336) and the same has been seen by Hon'ble Mr. Justice Rahul Chaturvedi, the then Administrative Judge, Pratapgarh Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 17.10.2023. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Sita Ram, Addl. District & Sessions Judge, Muzaffar Nagar, be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
