May kindly see the property statement online received from Sri Abhishek Gupta, Civil Judge (Junior Div.), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21(2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21(2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21(2019-20 & 2020-21), Gross income is Rs.13,05,814/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, PPF, repayment of car loan and the balance of his savings bank account(s) is enhanced by Rs.2,70,373/- in this financial year from previous year's balance, total of which is Rs.7,06,644/-. Thus, a sum of Rs.5,99,170/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statements at the time of joining in U.P. Judicial Service and the same has been approved by Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge Kaushambi Judgeship against Case Id : P00002282021 (Old Case Id : 2220).



It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21(2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21(2019-20 & 2020-21) vide online dated 21.10.2023. As such, there is delay in submitting the same from part of the officer, for which the officer verbatim :- "Your good self is further informed regarding the reason for the delayed filing of the desired information due to Institutional Training and some time lapsed to collect the documents and statements from the banks, due to which I could not submit my property statement. The inconvenience caused in your good self is highly regretted. I sincerely apologise for the same", as mentioned in remark column.

May, therefore, if approved, property statements for the financial years 2019-21(2019-20 & 2020-21) of Sri Abhishek Gupta, Civil Judge (Junior Div.), Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
