May kindly see the property statement online received from Dr. Nidhi Yadav-I, Additional Chief Judicial Magistrate, Firozabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2021-23 (2021-22 & 2022-23), her gross income from salary is Rs.34,32,879/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Mutual Funds, Repayment of home loan, NSC and Insurances are Rs.26,12,252/-. The balance of Rs.3,97,975/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.12,18,602/- (Rs.8,20,627/- from salary and Rs.3,97,975 from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of herself for the financial years 2021-23 (2021-22 & 2022-23).

In this connection, it is submitted that the Officer has already submitted her property statement up to the the financial years 2019-21 (2019-20 & 2020-21) online against case id-P00054212022, which had already been seen by Hon'ble Mr. Justice J.J. Munir, the then Administrative Judge, Pratapgarh Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide dated 04.10.2023 on eServicesJo portal. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Dr. Nidhi Yadav-I, Additional Chief Judicial Magistrate, Firozabad be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
