

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Smt. Shuchi Srivastava, Additional Principal Judge, Family Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income is Rs.43,37,443/- and total deductions/savings/investment against GPF, GIS, Income Tax, PPF, LIC, RD, Housing loan and the balance of her bank account(s) is also enhanced by Rs.2708/- in this financial year from previous year's balance, total of which is Rs.31,24,002/-. Thus, a sum of Rs.12,13,441/- was therefore available with her to meet out the household expenditure of her family consisting three members in both of the financial years.

It is pertinent to mention here that officer's husband is also working as Medical Officer, having monthly income of Rs.1,25,000/- as mentioned by the officer.

In this connection, it is submitted that the Officer has already submitted her property statement upto the the financial year 2018-20 and the same has also been approved by Hon'ble the then Chief Justice, online against Case Id : P00003952020.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted her movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 26.09.23. As such, there is delay in submitting the same from the part of officer for which the officer has stated (in her verbatim) that "I apologize for delay submission, the reason is due to transfer from Allahabad to Lucknow and some personal problems", as mentioned by the officer in remark column.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Smt. Shuchi Srivastava, Additional Principal Judge, Family Court, Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders ?
