In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.13,88,616/- and total deductions/savings/investment against NPS, GIS, PPF, Loan repayments and Income Tax is Rs.3,94,344/- and the balance of his savings bank account(s) is also increased by Rs.32,786/- in this financial year from previous year's balance, total of which is Rs.4,27,130/-. Thus, a sum of Rs.9,61,486/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2019-2021 (2019-20 & 2020-21).

It is pertinent to mention here that his father has monthly income of Rs.37,000/- through pension of Army Ex-serviceman.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining online against Case Id : P00004082021 (Old Case Id : 2434) and the same has been processed before Hon'ble Mr. Justice Manoj Bajaj, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 25.09.2023. As such, there is delay in submitting the same from the part of the officer for which officer has stated that "due to covid 19. I could not get my account details on time and could not submit the statement in time. Sincere apologies and prayer to condone delay. Highly obliged." in the remark column.
