May kindly see the online property statements received from Sri Abhinitam Upadhyay, Additional District & Sessions Judge, Balrampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income (including arrears) is Rs.44,64,606/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, Car loan, PPF a/cs, PLI, Insurance policies, Sukanya Samriddhi Yojna, Home loans and the balance of his savings bank account(s) has also been enhanced for Rs.2,36,019/- this financial year from previous year's balance, total of which is Rs.29,41,259/-. Thus, a sum of Rs.15,23,347/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife earns annual income of Rs.5,18,053/- and Rs.5,77,667/- in the financial years 2020-21 & 2021-22 respectively from Advocacy.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2019-20, which had already been seen online by Hon'ble Mr. Justice Mr. Subhash Vidyarthi, the then Administrative Judge, Balrampur in Case Id : P00000632020 | Old Case Id : 612.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 firstly vide online dated 29.09.2023. As such, there is delay in submitting the same for which he has stated that "delay occurred due to heavy workload. thus it is prayed that delay may be condoned", mentioned in his reply dated 06.04.2024.

May, therefore, if approved, property statements of the financial year 2020-21 & 2021-22 of Sri Abhinitam Upadhyay, Additional District & Sessions Judge, Balrampur be laid before Hon'ble Mr. Justice Ram Manohar Narayan Mishra, Administrative Judge, Balrampur for His Lordship's kind perusal and orders?
