May kindly see the online property statements received from Sri Vijay Kumar Dungrakoti, Additional District & Sessions Judge, Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, Total income are Rs.31,23,433/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Car loan, Insurance policies, PPF a/c and the balance of his savings bank accounts has been enhanced for Rs.7,04,437/- in this financial year from previous year's balance, total of which is Rs.21,38,163/-. Thus, a sum of Rs.9,85,270/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that his wife is Judicial officer in Uttarakhand having annual income of Rs.7,55,841/- and Rs.8,10,233/- in the financial years 2016-17 & 2017-18 respectively.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2011-12, which has already been seen by Hon'ble Mr. Justice V.K.Shukla, the then Administrative Judge, Ghaziabad, placed in the misc. file of the officer. And for the property statement of the financial years 2012-14 & 2014-16, detailed online notes have been submitted on e-Service IDs P00007512023 & P00007562023 respectively, for His Lordship's kind perusal & order.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 firstly vide online dated 29.09.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated that "officer had not submitted property statements till 2022-23 due to unavailability of bank statements related to the year 2012. He has neither purchased nor sale any properties after the financial year 2012-13. So, he could not submit any statements after 2012-13 to the financial year 2019 due to confusion/mistake. Officer has submitted offline property statements of the financial years 2014-15, 2016-17 and 2018-19 on 16.05.2019 but that's submission was not in the correct block. Now, he has uploaded all the required statements of the financial years 2012-22 on e-Service portal. He has requested to consider the aforesaid statements and in future, he will submit the further statements in correct block and within time", mentioned in officer's letter dated 29.09.2023 which is attached with the property statements of 2012-14.

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Vijay Kumar Dungrakoti, Additional District & Sessions Judge, Pilibhit be laid before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
