May kindly see the property statement received online from Smt. Kavita Agrawal, Chief Judicial Magistrate, Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2015-17 (2015-16 & 2016-17), Gross income from salary is Rs.10,53,973/- and total deductions/savings/repayment/investment against GIS, NPS, Income Tax, LIC & other policies, PPF and the balance of her saving bank account is also enhanced by Rs.5,13,121/- in this financial year from previous year's balance, total of which is Rs.9,27,047/-. Thus, a sum of Rs.1,26,926/- was therefore available with her to meet out the household expenditure of her family consisting three members in both of the financial years. It is pertinent to mention here that officer's husband is working as Additional Civil Judge (Junior Div.) and his annual income is Rs. 6,00,799/- & Rs.4,86,972/- for the financial years 2015-16 & 2016-17 respectively, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted her property statement upto the the financial year 2013-15 and the same has been processed online against Case Id : P00007692023 before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. She has submitted her movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) firstly vide her offline letter dated 22.09.18. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated that due to one year training after joining the service and judicial workload, she could not submit the aforesaid statement in due time for which she has apologised in her letter dated 22.09.2018.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Smt. Kavita Agrawal, Chief Judicial Magistrate, Muzaffarnagar be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
