May kindly see the property statement online received from Sri Ranvijay Singh, Additional Chief Judicial Magistrate (Railway), Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

***In the financial years 2015-17 (2015-16 & 2016-17)***, his gross income from salary is Rs.15,09,664/- and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF, NSC, Insurances and Mutual fund are Rs.4,35,525/-. The balance of Rs.13,481/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.10,87,620/- (Rs.10,74,139/- from salary and Rs.13,481/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2015-17 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of Joining in to U.P. Judicial Service online against case id-P00002072024 and same has been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) vide online dated 11.10.2023. As such, there is delay in submitting the same. In this regard, officer verbatim: "I unconditionally. Apologies for the delay in submitting my property statement for year 2015-17. Due to family engagement and challenges relating to family, I couldn't able to adhere the deadline. I assure that I am committed to meeting all future deadline promptly."

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Ranvijay Singh, Additional Chief Judicial Magistrate (Railway), Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
