In the financial years 2021-23 (2021-22 & 2022-23), his gross income from salary is Rs.34,09,528/and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF, NSC, Insurances and Mutual fund are Rs.9,77,872/-. The balance of Rs.23,456/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.24,55,112/- (Rs.24,31,656/- from salary and Rs23,456/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2021-23 (2021-22 & 2022-23).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id-P00014072021 and same has been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 11.10.2023. As such, there is no day delay in submitting the same.
