May kindly see the property statement received online from Sri Man Mohan Singh, A.D.J. (POCSO), Hardoi, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary is Rs.17,14,604/- and total deductions/savings/investment against GIS,NPS, PPF, Insurances, Car Loan repayments including down payments and Income Tax is Rs.6,32,588/- and the balance of his savings bank account(s) is also increased by Rs.42,597/- in this financial year from previous year's balance, total of which is Rs.6,75,185/-. Thus, a sum of Rs.10,39,419/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2017-18 (19.02.2018-31.03.2018 as the officer has joined U.P. Judicial Services on 19.02.2018) & 2018-19.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining offline and the same has been seen by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Mainpuri Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 20.10.2023. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer stated in his attachment dated 17.10.2023, that he had sent the movable and immovable property statement for the financial year 2018-2020 along with clarification on 09.12.2021, on which the Hon'ble Court, through objection, asked to submit the movable and immovable property statement for the financial year 2017-2018 (19.02.2018 to 31.03.2018 and 01.04.2018 to 31.03.2019) and also for the financial year 2019-2021 and 2021-2023, in compliance with which he has submitted the revised property statement. Further, he has stated that the delay caused due to ignorance regarding technical formalities, unavoidable circumstances arising out of Covid-19 and demise of his mother, for which he apologised and assured that he will endeavour to send property details on time and regularly in future.

In the reference to above explanation, it is submitted that the officer has submitted the property statement for the financial year 2018-2020 along with explanation for delay on 10.12.2021 through Case Id :P00022642021 (Old Case Id : 4393). After perusal, objection had been raised and in compliance with, the officer withdrew the above mentioned property statement and submitted a fresh property statement for the financial year 2017-2019 through Case Id : P00007832023 on eServicesJO portal.

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Sri Man Mohan Singh, A.D.J. (POCSO), Hardoi, be laid before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Hardoi Judgeship for Her Lordship's kind perusal and orders?
