

## **Registrar(J)(Budget)**

May kindly see the property statement submitted online received from Sri Neel Kant Mani Tripathi, Registrar (J)(Litigation), High Court, Allahabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

**In the financial years 2021-23 (2021-22 & 2022-23)**, income from salary and other sources is Rs.63,32,189/- (Rs.50,89,233/- from salary and Rs.10,40,628/- maturity of Birla Sun Life/- and Rs.2,02,328/- form Bank interest through FD) and total deductions/ repayment/ savings/ investment (for both the financial years) against Deposits in Saving bank account, GIS, NPS, Income Tax, Insurance policies, mutual fund (SIP), Repayment of home loan, Sukanya Samridhhi Yojna and NSC are Rs.49,76,270/-. The balance of Rs.12,70,985/- has increased from his saving bank A/c's against the balance of the previous year. Thus, a sum of Rs.13,55,919/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that officer's wife (Deputy Commissioner Commercial Tax in U.P. Government) having annual income 27,00,000/- approximately for the financial years 2021-22 and 2022-23 respectively.

In this connection, it is submitted that the officer has submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id-P00001062023, which had already been seen by Hon'ble The Chief Justice, High Court, Allahabad.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-23 (2021-22 & 2022-23) vide online dated 17.08.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2021-23 (2021-22 & 2022-23) of Sri Neel Kant Mani Tripathi, Registrar (J)(Litigation), High Court, Allahabad be laid before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
