

**Registrar(J)(Budget)**

May kindly see the online property statement received from Sri Narendra Kumar Jha, Presiding Officer, Motor Accident Claims Tribunal, Chandauli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total Gross income is Rs.41,75,906/- (arrear of 15% on Basic Salary and one month leave salary included) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income tax, PRAN, Car loan, LIC policies and the balance of his savings bank account(s) is enhanced for Rs.2,51,168/- this financial year from previous year's balance, total of which is Rs.20,05,185/-. Thus, a sum of Rs.21,70,721/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into judicial service and of the financial years 2013-15 which had already been submitted offline in the misc. file of the officer, before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Chandauli for His Lordship's kind perusal & order. The Property statement of the financial years 2015-16 & 2016-17, detailed online note has been submitted on e-service ID no.968.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 18.05.2020. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 (2017-19) of Sri Narendra Kumar Jha, Presiding Officer, Motor Accident Claims Tribunal, Chandauli be laid before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Chandauli for His Lordship's kind perusal and orders?
