

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Jeevak Kumar Singh, Civil Judge (Senior Div.), Auraiya, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2017-2019 (2017-18 & 2018-19)**, the Gross income from salary is Rs.23,60,014/- (Rs.16,40,014/- from salary, Rs.5,00,000/- from Agriculture and Rs.2,20,000/- from interest and other allowances) and total deductions/savings/investment against GIS, NPS, PPF, RD, Car Loan repayments, and Income Tax is Rs.6,96,056/- and the balance of his savings bank account(s) is also increased by Rs.13,75,635/- in this financial year from previous year's balance, total of which is Rs.20,71,691/-. Thus, a sum of Rs.2,88,323/- was therefore available with him to meet out the household expenditure of his family consisting two members of the financial year 2017-2019 (2017-18 & 2018-19) which seems to be meagre amount. In this regard, the officer has stated in his online reply dated 03.05.2024, that *"my wife was studying at my in-law's house, so this amount was enough for me as individual and due to agricultural family background, I didn't need to buy most of the edible items."*

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id : P00053492022 and the same has been processed before Hon'ble Mr. Justice Manish Kumar Nigam, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 21.10.2023. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer stated in the remark column, that *"the delay occurs due to rush of work and paucity of time. The inconvenience cause is deeply regretted."*

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Sri Jeevak Kumar Singh, Civil Judge (Senior Div.), Auraiya, be laid before Hon'ble Mr. Justice Manish Kumar Nigam, Administrative Judge, Auraiya Judgeship for His Lordship's kind perusal and orders?
