May kindly see the property statement online received from Sri Gajendra Singh, Additional Civil Judge (Senior Div.), Jalaun at Orai regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2020-22 (2020-21 & 2021-22), his total income from salary is Rs.25,99,432/- and total deductions/savings/investments/repayment against GIS, NPS, Income Tax, PPF A/c, SBI policy, car loan & personal loan, is Rs.11,42,438/-. Thus a sum of Rs.14,56,994/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 14,15,455/- in this financial year from previous year's balance. The Officer has also mentioned that his mother is having annual income of Rs.02 Lacs (approx.) from agricultural land and his wife is UPPCS (J) (2006 batch).

In this connection, it is submitted that the officer has already submitted his property statements upto the financial years 2018-20 which has already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Mathura, online against Case Id : P00009412020 (Old Case Id : 1828).

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto 31st March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 27.10.2023. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Gajendra Singh, Additional Civil Judge (Senior Div.), Jalaun at Orai be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders?
