

## **Registrar(J)(Budget)**

May kindly see the online property statements received from Sri B.Narayanan, ADJ(FTC)(14th Finance Commission), Agra, submitted on 12.01.2024, through which he has submitted his movable and immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service i.e.. His joining date is 21.01.2023.

In this connection, it is submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement held at the time of joining into U.P. judicial service just after joining into Judicial Service. He has submitted the aforesaid online property statement firstly on 12.01.2024. As such, there is delay in submitting aforesaid property statement from the part of the officer. In another matter of purchase of car by him, Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra has been pleased to pass an order dated 23.08.2024 that...**property statement after joining has not been submitted by the officer. Explanation with property statement to be put up within 15 days.** Accordingly, on this submitted property statement, vide communication dated 24/08/2024, he was asked to submit reasons for the delay in submitting the property statement held at the time of joining the U.P. Judicial service within two days along with certain details like the date the fixed deposit was taken, the maturity date, the name and quantity of shares with their price value, and the amount of the sovereign gold bond.

In reply, the officer has submitted the following in Verbatim:

*"I was intimated that the property statement can be filed only through my e-service portal. **My e-service portal was not active till 1st June 2023.** In this regard a letter was also sent to the Hon'ble High court, Allahabad. In response to the said letter a reply was received on 15/12/23, letter No.16092/IV-5448/Admin (A-4) stating that my e-service portal was already active and I was directed to submit the property statement. Since the online portal was activated only at a later stage the property statement could not be filed on time. I regret the delay caused due to the reason mentioned above and request your good self to kindly condone the delay.*

*The details with respect to Fixed deposits, share details and sovereign gold bond are attached as a separate document for your convenience."*

In this connection, the office further submits and like to mention here that regarding his submission, a report from the office of Registrar (J) (CPC) has been obtained, wherein the office of Registrar (J) (CPC), who is maintaining the e-service portal of Judicial officers, in its report dated 28.08.2024 has stated that the eServicesJO portal ID of Sri B. Narayanan, ADJ (FTC) (14th Finance Commission), Agra, was created on 23.03.2023, at 1:32:21 PM. However, the officer has reported that his eServicesJO portal was not active till 1st June 2023, which appears to be not correct.

May, therefore, if approved, movable & immovable property statement at the time of entering i.e., of joining into U.P. Judicial service of Sri B.Narayanan, ADJ(FTC)(14th Finance Commission), Agra alongwith his explanation be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgship for His Lordship's kind perusal and orders, in compliance of His Lordship's order dated 23.08.2024 passed in separate Case Id : S00039632024?
