May kindly see the property statement received online from Sri Sumit Gupta-I, Judicial Magistrate, Lucknow, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.12,22,247/- and total deductions/savings/investment against GIS, NPS, Insurances and Income Tax is Rs.2,10,064/- and the balance of his savings bank account(s) is also increased by Rs.1,12,099/- in this financial year from previous year's balance, total of which is Rs.3,22,163/-. Thus, a sum of Rs.9,00,084/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2019-2021 (2019-20 & 2020-21).

It is pertinent to mention here that his father have annual income of approx. Rs.2.4 lakhs as shopkeeper.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into U.P. Judicial Service, online against Case Id : P00012372021 (Old Case Id : 3339) and the same has been seen by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Lucknow Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 30.10.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated that (in his verbatim) "*due to covid-19 pandemic restriction, I was unable to get the details from my home district. I tender my apology for the delay and will not repeat the same*", in the remark column.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Sumit Gupta-I, Judicial Magistrate, Lucknow, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
