May kindly see the property statement online received from Sri Dharam Veer Singh, Chief Judicial Magistrate, Kannauj regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2021-23 (2021-22 & 2022-23)**, his gross income from salary and sale of plot are Rs.45,00,139/- ( Rs.32,81,639/- from salary and Rs.12,18,500/ from sale of plot) and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF, SSY, Insurances, Mutual Funds and Repayment of Car Loan are Rs.37,06,450/-. The balance of Rs.1,20,527/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.9,14,216/- (Rs.7,93,689/- from salary and Rs.1,20,527/- from withdrawal from saving bank account) was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2021-23 (2021-22 & 2022-23).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id- P00046712021 (old case id-6828) and same has been processed before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 09.11.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Dharam Veer Singh, Chief Judicial Magistrate, Kannauj be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders?
