In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-22 & 2022-23 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2021-22 & 2022-23, Total income from salary is Rs.18,94,079/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, PPF, NPS, Income Tax, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.1,86,576/- this financial year from previous year's balance, total of which is Rs.14,14,932/-. Thus, a sum of Rs.4,79,147/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

It is pertinent to mention here that his wife is also a Judicial Officer having monthly income of Rs.1,35,000/- & Rs.1,50,000/- in the financial years 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial 2010-11 which has already been seen by Hon'ble Mr. Justice V.K.Shukla, the then Administrative Judge, Bareilly, placed in the misc. file of the officer. And property statement for the financial years 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 and 2016-17 of the officer concerned has been laid offline before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer. Property statements for the financial years 2017-19 & 2019-21 which had been processed online and detailed online notes has been submitted before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders, on e-service IDs 5622 & 5634 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2021-22 & 2022-23 in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-22 & 2022-23 firstly vide online dated 08.11.2023. As such, there is no delay in submitting the same.
