May kindly see the property statements received on e-Services portal from Sri Divesh Chandra Samant, Special-Officer Vigilance, High Court, Allahabad regarding submission of revised property statements of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) on proper proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per revised statements of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary is Rs.52,44,594/total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax, Repayment of loans, Insurances, PPF, Sukanya Samriddhi Yojna, NSC, Mutual Funds, GVR is Rs.37,93,955/-. The balance of Rs.8,54,823/- has increased from his saving bank a/cs against the balance of the previous year. Thus a sum of Rs.14,50,639/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2020-22 (2020-21 & 2021-22).

The movable and immovable property statement for the financial years 2020-22 (2020-21 and 2021-22) had been submitted by the Officer earlier also through online e-Services portal on 08.05.2023, the same was already processed and already been 'Seen' by Hon'ble The Chief Justice in offline mode on 22.05.2023, placed in the Misc. file of the Officer. The Officer has again submitted the same as revised property statement for the financial years 2020-22 (2020-21 & 2021-22) on eServicesJO portal today by stating its reason (as attachment) that he submitted his property statement up to the financial years 2020-22. Recently, it came to his knowledge that some jointly held ancestral property (agricultural land) in the name of his father late Dr. Prem Chandra Samant, details given in the online proforma and attached khatauni, are situated in the District- Siddharthnagar. Since no partition took place and mutation is not done in some khatauni, inadvertently, the information thereof could not be given in his previous property statements, for which he apologize. He is submitting his revised property statements for the financial year 2020-2022 to the extent of agricultural land."

In this connection, it is submitted that Sri Divesh Chandra Samant had already submitted his property statement for the financial years 2018-20 (2018-19 and 2019-20), which has already been seen by Hon'ble The Chief Justice, High Court, Allahabad in the Misc. file of the officer. Subsequent property statement for the financial years 2020-22 (2020-21 and 2021-22) had been submitted by the Officer earlier also through online e-Services portal on 08.05.2023, the same was already processed and already been 'Seen' by Hon'ble The Chief Justice in offline mode on 22.05.2023, placed in the Misc. file of the Officer. The said property statement was processed as per declaration submitted by the officer about his properties. Now, as the officer himself has submitted revised property statement for the abovementioned financial years (2020-22) by accepting its deficiency with regard to ancestral property acquired through inheritance, the same appears to be considerable and hereby put up for placing the same before Hon'ble The Chief Justice again. The ancestral property freshly declared by the officer now is mentioned from Sl. no. 3 to 10 in the proforma "Land held in the Financial year 2020-2022".

Under the facts and circumstances, may, if approved, the revised movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Divesh Chandra Samant, Special-Officer Vigilance, High Court, Allahabad be laid before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
