May kindly see the online property statements received from Sri Sanjai Veer Singh, Principal Judge, Family Court, Sant Kabir Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2021-22 & 2022-23 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-22 & 2022-23 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2021-22 & 2022-23, Total income from salary is Rs.47,50,573/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, PPF, Income Tax, Insurance policies, Car loan and the balance of his savings bank account(s) has been enhanced for Rs.15,92,283/- this financial year from previous year's balance, total of which is Rs.35,83,990/-. Thus, a sum of Rs.11,66,583/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement for the financial years 2015-17, which had already been seen online by Hon'ble Mr. Justice Raj Beer Singh, the then Administrative Judge, Amroha on e-service ID P00053562022. And property statements for the financial years 2017-19 & 2019-21, detailed notes have been submitted before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders on e-service IDs P00000052020 & P00065432022 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2021-22 & 2022-23 in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-22 & 2022-23 vide online dated 17.11.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2021-22 & 2022-23 of Sri Sanjai Veer Singh, Principal Judge, Family Court, Sant Kabir Nagar be laid before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders?
