May kindly see the property statement submitted online from Sri Ashok Kumar Srivastava, Jt. Registrar (J)(S&A), High Court, Allahabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-2023 (2021-22 & 2022-23), Gross income from salary is Rs.47,62,654/and total deductions/ repayment/ savings/ investment against DCI, GIS, NSC, Income Tax, PPF, SIPs, RD, Insurance policies and Car Loan repayments including down payment is Rs.22,97,081/-. Thus, a sum of Rs.24,65,573/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years. The balance of Rs.89,991/- has decreased from his saving bank a/cs against the balance of the previous year.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2019-2021 (2019-20 & 2020-21) which has already been seen Offline by Hon'ble the Chief Justice on 31.01.2023, placed in the Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-2023 (2021-22 & 2022-23) vide online dated 08.11.2023. As such, there is no delay in submitting the same.

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at High Court, Allahabad.

May, therefore, if approved, property statements of the financial years 2021-2023 (2021-22 & 2022-23) of Sri Ashok Kumar Srivastava, Jt. Registrar (J)(S&A), High Court, Allahabad be laid before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
