May kindly see the property statement online received from Sri Kamla Pati-I, Special Judge (SC/ST, Prevention of Atrocity Act.), Azamgarh, regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary and allowances are Rs.40,61,659/- and total deductions/Savings/investments GPF, GIS, Income Tax, Repayment of home loan, Insurance and PPF are Rs.21,87,251/-. The balance of Rs.5,938/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.18,74,408/- was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2020-22 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id- P00003412020 (old case id-1011), which had already been seen by Mr. Justice Pankaj Naqvi, the then Administrative Judge, Shahjahanpur.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 19.12.2023. As such, there is delay in submitting the same. In this regard officer has submitted online reply dated 09.05.2024 that (Verbatim): "I would like to express my sincere apologies for the delay in submitting the property statement. Unfortunately, the delay can be attributed to the significant workload I have encountered in fulfilling my court duties, along with a delay in obtaining the necessary documentation from the bank."

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Kamla Pati-I, Special Judge (SC/ST, Prevention of Atrocity Act.), Azamgarh be laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Azamgarh Judgeship for His Lordship's kind perusal and orders?
