May kindly see the property statement online received from Sri Krishna Kumar-VI, Additional Principal Judge, Family Court, Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2021-23 (2021-22 & 2022-23), Gross income from salary and other sources (profit in Demat A/c) is Rs.49,48,788/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, car loan, PLI, PPF, Bajaj Policy, Sukanya Samridhi Yojna, purchase of jewellery, Mutual Fund & Shares and the balance of his savings bank account(s) is also enhance for Rs.1,04,908/- in this financial year from previous year's balance, total of which is Rs. 34,34,076/-. Thus, a sum of Rs.15,14,712/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial years 2019-21 online against case id- P00039952021 and the same has been also been processed online before the Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-23 (2021-22 & 2022-23) vide online dated 29.11.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-23 (2021-22 & 2022-23) of Sri. Krishna Kumar-VI, Additional Principal Judge, Family Court, Barabanki be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Barabanki for His Lordship's kind perusal and orders?
