May kindly see the property statement received online from Smt. Sonali Poonia, Addl. Chief Judicial Magistrate, Baghpat regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from salary and income from other sources i.e. interest of FDR etc. is Rs.38,71,123/- and total deductions/ repayment/ savings/ investment against GIS, NPS, RD, FD, Income Tax, PPF and Sukanya Samriddhi Yojna are Rs.27,52,344/-, and the balance of her savings bank account is also increased by Rs.6,40,371/- in this financial year from previous year's balance, total of which is Rs.33,92,715/-. Thus, a sum of Rs.4,78,408/- was therefore available with her to meet out the household expenditure of her family consisting six members of the financial year 2021-2023 (2021-22 & 2022-23).

It is pertinent to mention here that her husband is a Judicial Officer, have annual income of Rs.16,42,520/- & Rs.18,16,744/- in the F.Y. 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00029052021 (Old Case Id : 5046) and the same has been seen by Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Baghpat Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 29.11.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Smt. Sonali Poonia, Addl. Chief Judicial Magistrate, Baghpat, be laid before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders?
