

## **Registrar(J)(Budget)**

May kindly see the online property statement received from Smt. Chhaya Nain, Addl. District & Sessions Judge, Deoria regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

**(1) In the financial years 2016-17 & 2017-18**, Total Gross income from salary is Rs.22,49,509/- and total deductions/ repayment/ savings/ investments (for both the financial years) against GIS, NPS, Income Tax, PPF and LIC are Rs.7,10,609/-. Thus, a sum of Rs.15,38,900/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years. And the balance of her savings bank account(s) has also reduced for Rs.1,49,426/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is also a Judicial officer and having annual income of Rs.12,01,436/- and Rs.12,00,500/- in the financial years 2016-17 & 2017-18 respectively.

In this connection, it is submitted that officer has already submitted her property statement upto the financial years 2015-16 which had already been seen by Hon'ble Mrs. Justice Vijay Lakshmi, the then Administrative Judge, Hamirpur, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 firstly vide offline dated 05.04.2019. As such, there is some delay in submitting the same from the part of the officer for which she has stated that "Corona period was also held in the year of 2020 and 2021 due to which property statement can't be submitted online timely. She apologize and request to accept & consider it. She will be highly obliged", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial year 2016-17 & 2017-18 of Smt. Chhaya Nain, Addl. District & Sessions Judge, Deoria be laid before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders?
