May kindly see the property statement received online from Sri Bhagat Singh, Addl. Civil Judge (Senior Div.), Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from Salary and income from other sources i.e. interest of FDR etc. is Rs.35,92,027/- and total deductions/savings/investment against NPS, GIS, loan repayments and Income Tax is Rs.11,27,429/- and the balance of his savings bank account(s) is also increased by Rs.20,05,886/- in this financial year from previous year's balance, total of which is Rs.31,33,315/-. Thus, a sum of Rs.4,58,712/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2021-2023 (2021-22 & 2022-23).

It is pertinent to mention here that his wife is also a Judicial Officer, have annual income of Rs.18,42,136/- & Rs.20,28,987/- in the F.Y. 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00029562021 (Old Case Id : 5098) and the same has been seen by Hon'ble Mr. Justice Subhash Vidyarthi, the then Administrative Judge, Ramabai Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 06.01.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Sri Bhagat Singh, Addl. Civil Judge (Senior Div.), Baghpat, be laid before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders?
