May kindly see the property statement received online from Sri Sarvjeet Kumar Singh, A.D.J.(FTC), Gonda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross salary is Rs.42,81,768/- and total deductions/savings/investment against GIS, CPF, Income Tax, PPF, SSA, Insurance & PLI is Rs.19,55,193/-. Thus, a sum of Rs.23,26,575/- was therefore available with him to meet out the household expenditure of his family consisting five members in both of the financial years. And the balance of his savings bank account(s) is also reduced by Rs.3,73,837/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements for the financial years 2018-20 and the same has been approved online against Case Id : P00002922021 (Old Case Id : 2298) by Hon'ble Mr. Justice Neeraj Tiwari, the then Administrative Judge, Gonda Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 07.12.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that "Due to illness of my mother and exact figures are not provided by banks and other authorities in time. Therefore, I did not submit property statement in time. Please place my unconditional apology before Hon'ble court for delay in submission of property statement."

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Sarvjeet Kumar Singh, A.D.J.(FTC), Gonda be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal and orders ?
