May kindly see the property statement submitted online from Sri Mahendra Kumar Rawat, Addl. District & Sessions Judge, Jalaun at Orai regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-2023 (2021-22 & 2022-23), Total income from Salary is Rs.40,69,342/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, Loan repayments including down payment and Insurance policies is Rs.25,61,610/- and the balance of his savings bank account(s) is also increased by Rs.73,541/- in this financial year from previous year's balance, total of which is Rs.26,35,151/-. Thus, a sum of Rs.14,34,191/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife have annual income of Rs.3,60,000/- from Advocacy and Rs.4,32,000/- from House Rent in both financial year.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2019-2021 (2019-20 & 2020-21) online vide Case Id: P00006862021 (Old Case Id : 2746) and the same has been seen by Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial years 2021-2023 (2021-22 & 2022-23) vide online dated 19.02.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2021-2023 (2021-22 & 2022-23) of Sri Mahendra Kumar Rawat, Addl. District & Sessions Judge, Jalaun at Orai, be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders?
