

## **Registrar(J)(Budget)**

May kindly see the online property statement received from Dr. Ajay Kumar-II, District & Sessions Judge, Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income is Rs.70,11,910/- (total annual income from salary, D.A., T.A., Other allowances, IR etc of Rs.66,82,146/-, income from sale of Car of Rs.1,50,000/- and Interest from saving a/c of Rs.1,79,764/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, NPSA, Income Tax, GVR, LIC policies, PPF a/c, Home loan, Medical Insurance, Sukanya Samriddhi a/cs, SIP and the balance of his savings bank account(s) is also enhanced for Rs.5,59,969/- in this financial year from previous year's balance, total of which is Rs.48,79,397/-. Thus, a sum of Rs.21,32,513/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife started working as Executive Director cum Advisor in SKS College of Education having annual income of Rs.2,70,000/- and Rs.4,82,430/- in the financial years 2020-21 and 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2018-20 which has already been seen online by Hon'ble Mr. Justice Dinesh Kumar Singh, the then Administrative Judge, Moradabad.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 21.01.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that *"In Covid-19 pandemic, the undersigned was transferred from Muzaffarnagar to Shamli in July, 2020 and thereafter from Shamli to Moradabad in November, 2021. The undersigned is a 'Chronic Kidney Disease Patient' and was in stage III of the disease, when joined at Moradabad. Due to Covid-19 Pandemic situations, the requisite bank statements as well as details could not be collected and compiled. The undersigned got Covid at Moradabad and all the vital parameters of kidney function were badly affected as a result of Covid. After recovering from Covid, the undersigned got 'Chicken Pox', which further deteriorated all the vital parameters of kidney and thereby reduced the kidney function to about 10% only, resulting into progression into stage IV/V of the CKD from stage III. In these circumstances, the undersigned got treatment from AIIMS, New Delhi from Nephrologist Dr. R. K. Yadav. During this period, the undersigned along-with very hectic administrative and judicial duties also fought with illness of very advance stage of kidney disease i.e. stage IV/V of CKD and therefore could not send the information on time and the delay so caused is deeply regretted, which may kindly be condoned. It is, therefore, most respectfully submitted that the statement may kindly be taken on record"*, mentioned in remark column of Movable proforma.

May, therefore, if approved, property statements for the financial years 2020-21 & 2021-22 of Dr. Ajay Kumar-II, District & Sessions Judge, Moradabad be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgship for His Lordship's kind perusal and orders?
