

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Raghuvansh Mani Singh, Civil Judge (Senior Div.), Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2015-17 (2015-16 & 2016-17), Gross salary is Rs.13,64,371/- and total deductions/savings/investment against NPS, GIS, Income Tax, PPF, SSA, car loan and the balance of his savings bank account is enhanced by Rs.24,082/- in this financial year from previous year's balance, total of which is Rs.6,71,674/-. Thus, a sum of Rs.6,92,697/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both of the financial years. It is pertinent to mention here that officer's wife is Additional Civil Judge (J.D.) and her annual income is Rs.3,54,604/- and Rs. 4,67,919/- for the financial year 2015-16 & 2016-17, respectively, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2013-15 and the same has been processed online against Case Id : P00009332023 before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. The officer firstly submitted the property statement for the financial year 2015-16 & 2016-17 through his letter dated 22.09.2018 offline, but some required details were not furnished by him. Accordingly, Court's letters dated 12.11.2018 & 25.01.2022 were sent to the officer requesting him to submit revised property statements with the required information. Now the officer has submitted revised property statement for the financial year 2015-17, vide online dated 21.12.2023. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, he has attached a delay condonation application dated 21.12.2023 with the statement wherein he has stated that his father is a heart patient so he was busy in taking care of him due to health problems. And his wife continued undergoing treatment due to complications arising from the pregnancy. For these reasons he was much worried and the delay in submission of property statement is due to adverse circumstances, not intentional. Further the officer has requested to consider it sympathetically and forgive the delay. In future, he will furnish the statements with in time, as mentioned by the officer.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Raghuvansh Mani Singh, Civil Judge (Senior Div.), Muzaffarnagar be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
