May kindly see the property statement received online from Sri Rajesh Kumar Mishra, Addl. District & Sessions Judge, Gautambuddha Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from salary is Rs.48,26,397/- and total deductions/savings/investment against NPS, GIS, Insurances, loans repayments including down payments, allowances and Income Tax is Rs.25,77,058/-. Thus, a sum of Rs.22,49,339/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2021-2023 (2021-22 & 2022-23) and the balance of his savings bank account(s) is also decreased by Rs.7,09,661/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00015892021 (Old Case Id : 3704) and the same has been processed before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautambuddha Nagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 01.01.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Sri Rajesh Kumar Mishra, Addl. District & Sessions Judge, Gautambuddha Nagar, be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautambuddha Nagar Judgeship for His Lordship's kind perusal and orders?
