May kindly see the property statement online received from Sri Irfan Ahmad, Additional Director, Institute of Judicial Training & Research, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), his gross income from salary is Rs.32,48,370/- and total deductions/Savings/investments against NPS, GIS, Income Tax and Repayment of loans and Insurances are Rs.13,75,212/-. The balance of Rs.93,131/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.19,66,289/- (Rs.18,73,158/- from salary and Rs.93,131/- saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2016-18 (2016-17 & 2017-18).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2014-16 (2014-15 & 2015-16) online against case id- P0000042024 and same has been processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) vide online dated 13.02.2024. As such, there is delay in submitting the same. In this regard officer verbatim; "It is most humbly submitted that the delay in submitting property statement was on account of inadvertent oversight and burden of work. It is humbly requested to the kindness of the Honorable Court that the delay may kindly be condoned. I tender my sincere apology and i also undertake that i shall be careful in the future. Thanks".

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Irfan Ahmad, Additional Director, Institute of Judicial Training & Research, Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
