May kindly see the property statement received online from Sri Sanjay Kumar Yadav-I, Addl. District & Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary is Rs.43,38,191/- and total deductions/savings/investment against GIS, NPS, PPF, Mutual Funds, Insurances, Sukanya Samriddhi Account and Income Tax is Rs.20,68,852/-. Thus, a sum of Rs.22,69,339/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22) and the balance of his savings bank account(s) is also decreased by Rs.6,62,361/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife Smt. Asha Yadav working as Lecturer, Saket Girls Degree College, Dahilamau, Pratapgarh, have monthly income of Rs.15,000/- in both financial year as mentioned by the officer.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00042742021 (Old Case Id : 6427) and the same has been processed before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 08.01.2024. As such, there is delay in submitting the same from the part of officer, for which he stated in his application as attachment dated 06.01.2024, that by mistake, he could not send the movable and immovable property statements for the financial years 2020-2021 and 2021-2022 on time. For which he apologizes.
