May kindly see the property statement received online from Smt. Poonam-II, Additional Principal Judge, Family Court, Unnao regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2021-23 (2021-22 & 2022-23), Gross income is Rs.51,88,954/- and total deductions/savings/repayment/investment against NPS, GIS, Income Tax, PPF, LIC, sukanya samridhi, mutual funds, Insurance Policy, Home loan and the balance of her savings bank account(s) is also enhanced by Rs.1,59,794/- in this financial year from previous year's balance, total of which is Rs.30,67,299/-. Thus, a sum of Rs.21,21,655/- was therefore available with her to meet out the household expenditure of her family consisting of three members in both of the financial years. It is pertinent to mention here that her husband is also a judicial officer whose annual income is Rs.23,61,345/- & 24,56,071/- for the financial year 2021-22 & 2022-23, respectively.

In this connection, it is submitted that the Officer has submitted her property statements upto the financial years 2019-21 online and the same has been seen online against Case Id : P00006302020 by Hon'ble Mr. Justice Rajiv Gupta, the then Administrative Judge, Unnao Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. The officer has submitted her movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 01.07.24. As such, there is delay in submitting the same from the part of the officer. In this regard, the officer has stated that 'To fill the property statement of the financial year 2021-23, it took some time in collecting the details of mutual funds and other movable & immovable properties taken during this financial year, due to which there has been a delay of three months, for which the officer has apologised and in future she will make efforts to send the property statements within the stipulated time', as mentioned in her attachment letter.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Smt. Poonam-II, Additional Principal Judge, Family Court, Unnao be laid before Hon'ble Mr. Justice Samit Gopal, Administrative Judge, Unnao Judgeship for His Lordship's kind perusal and orders?
