<u>Registrar(J)(Budget)</u>

May kindly see the online property statement received from Sri Mohan Kumar, Additional District & Sessions Judge (POCSO), Ambedkar Nagar at Akbarpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22 (2020-21 & 2021-22), Total Gross income is Rs.38,24,487/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Insurance policies, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.4,25,378/- this financial year from previous year's balance, total of which is Rs.19,41,990/-. Thus, a sum of Rs.18,82,497/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2009-10 which had already been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Jalaun at Orai, placed in the misc. file of the officer. Subsequent property statements are also in submission, in which some/ separate orders have already been passed by Hon'ble Mr. Justice Abdul Moin, the then Administrative Judge, Lakhimpur Kheri. Orders of His Lordship have already been communicated to the officer in the same mode, as passed either offline or online in respective case IDs.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-22 firstly vide online dated 18.01.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated that he could not submit the aforesaid statements within time "Due to his wife's illness, he has not purchased any movable property worth more than Rs 10000 in the financial year 2020-2021 and exact figures are not provided by banks and other authority in time. However please place his unconditional apology before Hon'ble court for delay in submission of property statement", mentioned in officer's reply dated 30.01.2024.

May, therefore, if approved, property statements of the financial year 2020-22 (2020-21 & 2021-22) of Sri Mohan Kumar, Additional District & Sessions Judge (POCSO), Ambedkar Nagar at Akbarpur be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Ambedkar Nagar at Akbarpur Judgeship for His Lordship's kind perusal and further orders?
