May kindly see the online property statements received from Sri Pawan Kumar Rai, Additional District & Sessions Judge (F.T.C.), Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, total Gross salary is Rs.31,09,050/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF a/c, LIC policies, SIPs, Home loan and the balance of his savings bank account(s) has also been enhanced for Rs.34,347/- this financial year from previous year's balance, total of which is Rs.29,63,022/-. Thus, a sum of Rs.1,46,028/- was therefore available with him to meet out the household expenditure of his family consisting of six members in both the financial years.

It is pertinent to mention here that his wife is a lawyer having annual income of Rs.8 lacs and Rs.10 lacs in the financial years 2020-21 & 2021-22 respectively. His father is also a pensioner having annual pension of Rs.11.5 lacs and Rs.12 lacs in the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2018-20 online which has already been seen online by Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat on e-Service ID P00046862021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March,2023. He has submitted movable and immovable property statements for the financial years 2020-21 & 2021-22 firstly vide online dated 17.01.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that *"It is to submit that to take care of my mother after her medical treatment and due to my transfer from Lucknow to Baghpat Judgeship, I was unable to submit the statement on time. Property statement along with delay reason is hereby submitted for the kind perusal of Hon'ble Court."*, mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial years 2020-21 & 2021-22 of Sri Pawan Kumar Rai, Additional District & Sessions Judge (F.T.C.), Baghpat be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders?
