

## **Registrar(J)(Budget)**

May kindly see the online property statements received from Sri Ashish Jain, Principal Judge, Family Court, Mathura regarding submission of complete statement of movable properties acquired/held by him or any member of his family of the financial year 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

1. In the financial years 2021-23 (2021-22 & 2022-23), Total income is Rs.59,58,018/- (Gross income from salary are Rs.56,44,583/-, interest of SB a/c is Rs.1,05,435/- and matured amount of policy is Rs.2,08,000/-) and total deductions/savings/ investment against GIS, Income Tax, NPS, Mutual Fund, PPF a/c, loan, Sukanya Samriddhi a/cs and RD are Rs.43,47,440/-. Thus, a sum of Rs.16,10,578/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.4,23,161/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife earns annual income of Rs.4,60,800/- and Rs.5,10,800/- from tuition in the financial years 2021-22 and 2022-23 respectively.

In this connection, it is submitted that the officer has already submitted his property statement of the financial year 2019-21 online, which has already been seen online by Hon'ble Mr. Justice Om Prakash Tripathi, the then Administrative Judge, Sant Kabir Nagar.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March,2024. He has submitted movable and immovable property statements of the financial year 2021-23 (2021-22 & 2022-23) vide online dated 19.01.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Ashish Jain, Principal Judge, Family Court, Mathura be laid before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura for His Lordship's kind perusal and orders?
