May kindly see the online property statements received from Sri Rohit Singh, Special Judge (Ayurved Scam Matter), Lucknow regarding submission of complete statement of movable & immovable properties acquired/held by him or any member of his family of the financial year 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

1. In the financial years 2021-23 (2021-22 & 2022-23), Total Gross income from salary are Rs.44,46,032/- and total deductions/savings/ investment against GIS, Income Tax, NPS, Mutual Fund, PPF a/c and LIC policy are Rs.25,01,455/-. Thus, a sum of Rs.19,44,577/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both of the financial years. And the balance of his savings bank account(s) is also reduced for Rs.2,60,798/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife is also a Judicial Officer having annual income of Rs.19,36,195/- and Rs.22,57,312/- in the financial years 2021-22 and 2022-23 respectively.

In this connection, it is submitted that the officer has already submitted his property statement of the financial year 2019-21 online, which has already been seen online by Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow on eService ID P00037562021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March,2024. He has submitted movable and immovable property statements of the financial year 2021-23 (2021-22 & 2022-23) vide online dated 01.03.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Rohit Singh, Special Judge (Ayurved Scam Matter), Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
