May kindly see the property statement online received from Sri Akhil Kumar Nijhawan, Civil Judge (JuniorDiv.) Pharenda-Maharajganj regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2021-23 (2021-22 & 2022-23)**, his gross income from salary and sale of car are Rs.28,63,471/- ( Rs.22,48,471/- from salary and Rs.6,15,000/- from sale of old Car) and total deductions/Savings/investments against Deposits in Saving Bank Account, NPS, GIS, Income Tax, Purchase of New Car and Repayment of old Car Loan are Rs.25,69,788/-. The balance of Rs.13,07,090/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.2,93,683/- was therefore available with him to meet out the household expenditure of his family consisting two members in the financial years 2021-23 (2021-22 & 2022-23).

It is pertinent to mention here that officer's wife (Judicial officer) having annual income was Rs.11,00,000/- for the financial years 2021-22 & 2022-23 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id- P00063222022 , and same has been processed before Hon'ble Mr Justice Shree Prakash Singh, Administrative Judge, Maharajganj Judgeship for His Lordship's kind perusal and orders

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 21.02.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Akhil Kumar Nijhawan, Civil Judge (JuniorDiv.) Pharenda-Maharajganj be laid before Hon'ble Mr Justice Shree Prakash Singh, Administrative Judge, Maharajganj Judgeship for His Lordship's kind perusal and orders?
