May kindly see the property statement received online from Smt. Nitya Pandey, Addl. District & Sessions Judge Firozabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2019-2021 (2019-20 & 2020-21)**, the Gross income is Rs.38,04,385/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, PLI, Loan Repayment and Insurances are Rs.22,09,056/-. Thus, a sum of Rs.15,95,329/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2019-2021 (2019-20 & 2020-21) and the balance of her savings bank account is also decreased by Rs.9,76,762/- in this financial year from previous year's balance.

It is pertinent to mention here that her husband have annual income of Rs.1,50,000/- by Advocacy.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2017-2019 (2017-18 & 2018-19) offline and the same has been processed before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 07.02.2024. As such, there is delay in submitting the same from the part of the officer for which she has stated in her letter as attachment dated. 05.02.2024, that due to excess of work, some family problems & her illness, she could not submit property statement in compliance of Circular of Hon'ble High Court. There has been no deliberate disobedience by her in submission of property statements. Further, she apologizes for delay caused and assures that she will continue to sent property statements in time in future.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Smt. Nitya Pandey, Addl. District & Sessions Judge Firozabad, be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
