May kindly see the property statement received online from Smt. Nitya Pandey, Addl. District & Sessions Judge Firozabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2021-2023 (2021-22 & 2022-23)**, the Gross income from salary is Rs.43,50,646/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, PLI, Loan Repayment and Insurances are Rs.31,97,269/-, and the balance of her savings bank account is also increased by Rs.1,37,856/- in this financial year from previous year's balance, total of which is Rs.33,35,125/-. Thus, a sum of Rs.10,15,521/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2021-2023 (2021-22 & 2022-23).

It is pertinent to mention here that her husband have annual income of Rs.1,50,000/- by Advocacy.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00000672024 and the same has been processed before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 05.02.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Smt. Nitya Pandey, Addl. District & Sessions Judge Firozabad, be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
