May kindly see the property statement received online from Sri Husain Ahmad Ansari, Special Judge (E.C.Act), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income from salary is Rs.45,28,337/- and total deductions/savings/investment against GPF, GIS, Income Tax, PPF, LIC, PLI, GPF advance repayment, car purchase and the balance of his savings bank account is also enhanced by Rs.2,61,248/- in this financial years from previous year's balance, total of which is Rs.26,25,194/-. Thus, a sum of Rs.19,03,143/- was therefore available with him to meet out the household expenditure of his family consisting of six members in both of the financial years.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2018-20 and the same has already been processed online against Case Id : P00001402021 before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 21.02.24. As such, there is delay in submitting the same from the part of the officer. In this regard, he has stated (in his verbatim) that "Due to the rush of work, I could not recall and the moment it clicked to my memory, I immediately submitted the statement. However, I beg to be pardoned for the delayed submission of statements", as mention in his attachment letter dated 29.04.2024.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Husain Ahmad Ansari, Special Judge (E.C.Act), Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
