Sub: **Representation against overall remarks given by the District Judge in Annual Self Assessment 2019-2020 Case ID No. 554**

Sir,

It is humbly submitted that the remarks given by the District Judge in Annual Self Assessment for the year 2019-20, Case ID No. 554 were communicated to me through online portal on 15-08-2020.

It is submitted that with all due respect I humbly represent against the Remarks given by the District Judge in column number 02 , regarding Over all assessment of the merit of the Officer wherein I have been awarded "**Good**" entry by the respected District Judge.

I humbly beg to bring to kind notice of the Hon'ble Court that in his remarks, it has been recorded that I achieved 1829.63 units against target units 698.16 which is 262.06% and much above than target units. The details of old cases decided by me was also recorded by the District Judge. Apart from it, it was also mentioned that I decided 168 contested cases including old cases, 2 MACP relating to death/injury wherein just and proper compensation was awarded. It was specifically mentioned regarding execution that I took interest in deciding execution cases and decided 3 execution cases. The respected District Judge has also observed that I decided 12 civil cases on the basis of compromise/ ADR and total 548 cases also decided in Lok Adalats.

It is pertinent to mention here that during the assesment year 2019-20 my courts were also frequently changed. I presided over the court of Civil Judge (S.D) Aligarh (From 1-4-19 to 15-4-19)as well as C.J.M Jaunpur (from 18-4-19 to 30-7-19) before getting promoted to the cadre of H.J.S on 28-7-2019. Thereafter I presided over the Court of Additional District Judge (F.T.C) Jaunpur (from 30-7-19 to 21-8-19), A.D.J Jaunpur (from 21-8-19 to 18-11-19) and Additional Principal Judge, Family Court Jaunpur (from 18-11-19 to 31-3-20) and despite the above frequent change in courts I achieved 262.06% units and disposed old cases as well as contested cases.

Apart from it, I also contributed in administrative work which was entrusted to me. I was Officer Incharge Amins, Assistant Information officer and member Selecting Authority, District Court Aligarh, Incharge Security/protocol and Incharge police and civil copying at different point of times. Respected District judge also recorded as officer has effective control over the office and he possesses good administrative capacity and tact.

Therefore I most humbly submit that "Good" entry does not properly justfys the efforts which I put in judicial and administrative work during the assesment year and hence, it is most humbly prayed to the Hon'ble Court that the above mentioned facts may kindly be considered and the "GOOD" entry in column number 2 regarding the overall assesment may kindly be upgraded to any other higher suitable entry which the Hon'ble Court deems fit.

It is requested that my submission may kindly be placed before the Hon'ble Court for kind and sympathetic consideration.
