FOR THE YEAR 2018-19**



In the year 2018-19, the officer was posted as Judicial Magistrate-I, Gonda from 1.4.2018 to 23.4.2018; Civil Judge (JD)/FTC (New), Gonda from 24.4.2018 to 10.1.2019 and Civil Judge (JD) Gonda from 11.1.2019 to 31.3.2019. She was also officer-in-charge (Amin) from 11.1.2019 to 31.3.2019. The officer has disclosed turn over at 104.33%, which is rated to be adequate.

The District Judge, Gonda has reported that the officer had good control over his office and administrative capacity and cordial relations with members of the bar and brother officers. She is fair and impartial in dealing with the public and bar. She is cool minded and does not lose temper in Court. Her behaviour towards eomen is very respectful. She is punctual and regular in sitting on dais in Court during court hours. The District Judge has reported the integrity of the officer to be beyond doubt and the overall assessment of merit of the officer to be "Good".
